GENERAL CONDITIONS OF PLAY:

Regulations and Code of Conduct: As a condition of entry all players must acknowledge and agree to be bound by the Laws of the Sport of Bowls Crystal Mark 4th Edition dated 1 April 2023, BNZ Code of Conduct (Regulation 10) and Central Otago Code of Conduct as set down in the document dated 2 October 2022.

Affiliation & Eligibility: All players in Centre Events must be full financial members of a club affiliated to Bowls Central Otago.

Absentee players: (Law 39) If any player/s are absent in a team or side, the game may continue, and Law 39 will apply.

Catering: Morning and afternoon tea will be provided by the host club. Players will make their own arrangements for lunch unless otherwise stated.

Cell phones: Use is not permitted by players on or alongside the greens during play. Preferably, cell phones should be switched off or turned to silent.

Centre Titles: Players must be full financial members of the same Club except where otherwise stated. The following events qualify for a Centre Title:

- **Centre Open Tournaments** - Singles, Pairs, Triples, and Fours
- **Interclub Sevens** - Teams accepted from 2 clubs who have less than 20 members of same gender.
- **Mixed Pairs** – Composite teams accepted but will not be eligible to compete in the national playoff.
- **Champion of Champions** – Singles, Pairs, Triples and Fours
- **Gold Star:** Winners of Five Centre Titles, and multiples of, qualify for a Gold Star.

- **1-5 & 1-10 year:** These events do not qualify for a Centre Title.

Clothing: Players in a team or side must wear their club uniform.

Code of Conduct: As a condition of entry all players must acknowledge and agree to be bound by the Laws of the Sport of Bowls Crystal Mark 4th Edition dated 1 April 2023, BNZ Code of Conduct as set in Regulation 10 and Central Otago Code of Conduct as set down in the document dated 2 October 2022.

Controlling Body: The Controlling Body for these events is the Bowls Central Otago Match Committee. The Controlling Body will have the right to alter, add to or delete any conditions of play due to unfavourable weather and/or special conditions to enable the completion of the tournament. Each event will be under the control of a Tournament Manager appointed by Bowls Central Otago.

Delivery of the Jack: (Law 10) If the Jack is incorrectly delivered it will be returned to be replayed by the opposition.

Defaulters: No team entered in a team event or entrant in a singles event will withdraw from that event except in the case of illness of a player or other just cause. The Controlling Body may require evidence of the illness or other just cause to be submitted.

Disputes and Complaints: The Match Committee will act on complaints and playing disputes, provided they comply with Law 36 or 52.4. All Complaints and Disputes must be forwarded in writing, on the appropriate form, to: The Manager, Bowls Central Otago.

Draws: A list of Entrants will be published on Bowls Hub during the week prior to each event. An open, random draw will be conducted prior to the commencement of each open event on Bowls Hub. Post Section Draws will be advertised on Bowls Hub on the evening prior to the event. Random draws for Champion of Champion events will be made upon confirmation of entries from all clubs.

Where possible players/teams who have a bye in the first round will be advised prior to the event.

Dual Membership: If a player and/or player in a team WINS a club championship competition that qualifies them for a centre champion of champions event, they are ineligible to enter another club's competition in that discipline.

A player and/or player in a team can only win one club championship or centre Champion of Champions event per discipline in a single season. *For clarity, if a player wins any club championship, in any discipline, then they may NOT enter that same discipline at any other club, in any centre, in the same season.*

A player and/or player in a team, can only play in one active club championship discipline at any one time. *For clarity, the player may enter another club's (if they are full playing member) championship in the same discipline ONLY after the first club's championship in the same discipline has concluded and/or they are knocked out of that club's event.*

Entries: Entries close on Bowls Hub at 7.00 pm on the Sunday prior to each event, except where otherwise stated. Entries will not be accepted directly by Tournament Controllers. Late entries may be accepted at the discretion of the Tournament Secretary. Bowls Central Otago reserves the right to obtain extra entries to avoid byes

Entry Fee: Entry fee must be paid to Bowls Central Otago. BNZ Account 02 0916 0133831 00 (Bowls CO) by 5.00pm on the Monday before the event. Entries will not be included in the draw until payment has been confirmed.

Entry withdrawals: Any withdrawals must be notified to the appropriate Tournament Secretary 48 hours before the scheduled commencement of the event.

Laws and Regulations: All competitions must be played in accordance with the **Laws of the Sport of Bowls**, Crystal Mark Fourth Edition effective 1 April 2023

Leaving the Venue: No player shall leave a venue at any competition without reporting to the Umpire.

Practice Ends (Law 4.0): If a team/singles player has a bye in the first round of the day, they will be entitled to practice, on another available rink, which they will not be playing on during the day as designated by the Controlling Body. They will also be entitled to trial ends, on their first rink of play, along with their opponents. If a team has a bye in a subsequent round, they will only be entitled to practice on another available rink as designated by the Controlling Body.

Prizes: The awarding of prize money will be determined by Bowls Central Otago.

Score cards: Skips must keep the official score card and cannot delegate this responsibility. The official scorecard must be completed clearly and in full for every game. The names of all players and the time the game finished must be recorded. The card must be signed by the skips as a true record of the game.

Smoking/Vaping: Teams/Players visiting other Clubs must abide by the rules of the host Club. There is to Be NO SMOKING OR VAPING in clubrooms, on the greens, or surrounds at Centre Events. Smoking or Vaping to be in the Club's designated areas only or outside the Club boundaries.

Submissions for consideration for next season: Should you have any concerns or grievances that need to be brought to the attention of Bowls Central Otago. please submit these in writing where they will be dealt with appropriately.

Clubs to submit discussion points on changes to competitions by 31 January 2026. These will be discussed at a General Meeting in February. Clubs may choose to submit remits to be voted on at an April General Meeting.

Substitutes: (Domestic Regulation 2): Any change in playing personnel shall be subject to the prior approval of the Controlling Body and shall be limited to one Substitute in Pairs and Triples and two Substitutes in the Fours. No substitutes will be approved for Open Singles. The runner-up may Substitute for 1-5 competitions. Under no circumstances may a Substitute play in the position of Skip and teams must alter playing positions accordingly. All applications should be submitted to the appropriate Tournament Secretary as soon as possible. Application forms are available from the Bowls Central Otago website (www.bowlscentralotago.com), Tournament Secretary or Club Secretaries.

Trial Ends: (Law 5.1) Before the scheduled start of play each day, before continuing an unfinished game on another day or if changing greens during the day, one trial end may be played in each direction at the discretion of the Controlling Body. All players and bowls must be off the green at least 10 minutes prior to the scheduled commencement times of the event.

Use of Electronic Devices: Pursuant to Law 41.7, players with a hearing disability can use electronic devices to communicate with each other while on the rink of play, or with a marker in a singles game. Electronic devices should not interrupt or interfere with any other player or disrupt the flow of the game. The electronic device must non-intrusive to other players or officials that are present on the green at any time during a game. As a guide, the use of the device should be no more intrusive (in terms of volume) than any other conversation between players in any game.

INTERCLUB AND PENNANTS:

SATURDAY PENNANTS: PREMIER, DIVISIONS 1 & 2 CONDITIONS OF PLAY:

Teams: May consist of men or mixed teams.

Players: May move between divisions although this is not encouraged.

Start Time: 1.00pm unless otherwise advised

Match Format: Game 1 – 1 ½ hours - Fours Game 2 – All 1 ½ hours - 3 Bowl Pairs for Premier and Div 1, 2x4x2 for Div 2.

Team Format: Pairs combinations and opponents should be decided before commencement of fours and toss done to see which pair plays which.

Scoring:

Fours: 2 points for a win, 1 point for a draw

Pairs: 2 points for a win, 1 point for a draw

1 aggregate point to the team with the most points across both games. If the points are tied ½ point is awarded to both teams.

Killed End: A killed end is replayed unless it is after the bell when it is replaced on the 2 metre mark.

Incorrectly Delivered Jack: Placed by the opposing skip

Catering: Afternoon tea provided by the host club.

Games interrupted or called off: If a game is interrupted and subsequently no further play is possible due to inclement weather or any other valid reason, the following rules will apply:

- ☐ If play is called off before the fours game is complete, then there is no result
- ☐ If the fours are completed those points are awarded
- ☐ If the pairs have completed 6 ends the points will be awarded otherwise the points are shared
- ☐ If games cannot be played on the day they must be played before the next round OR the teams can share the points OR one club will need to default.

Defaults: If a club is unable to field all its teams on a Saturday it MUST default its lowest ranking team or teams. All defaults to be approved by the controlling body.

Duties of Host Club:

- ☐ Appoint a controller for the afternoon
 - ☐ Allocate rinks for all games before play commences and displayed for all players to see
 - ☐ Create scorecards which must include the discipline e.g. Premier, Pairs 1, Club vs Club and Rink No.
 - ☐ Ensure the toss is done to determine which pairs play each other
 - ☐ Start the event and be responsible for the bell/horn and time clock
- All results to be entered into Bowls Hub by the Host Club directly from cards, once signed.

Final Results Premier, Division 1 and Division 2:

- ☐ Each team accumulates points, in their own right, during the round robin.
- ☐ At the completion of the round robin in Premier and Division 1, the top four teams will progress to the semi-finals. 1st vs 4th and 2nd vs 3rd will apply. The winner of each game plays off in the final. The losers may play off to determine 3rd and 4th.
- ☐ At the completion of the round robin in Division 2 the top two teams in their respective sections will progress to the semi-finals. 1st v 2nd from each section will apply.
- ☐ 1st section 1 vs 2nd section 2
- ☐ 2nd section 1 vs 1st section 2
- ☐ The winner of each game plays off in the final. Losers may play off to determine 3rd and 4th.

Restrictions:

Premier:

- ☐ Only players who have played a minimum of five pennants rounds (in any division) can play for their team on finals day.
- ☐ Once a player has played five pennants rounds in the Premier division, he or she is ineligible to play in Division 1 or 2.

Divisions 1 & 2:

- ☐ Only players who have played a minimum of five pennants rounds in a particular team can play for that team on finals day should it qualify.
- ☐ The Hurley Cup will be awarded to the winners of the Premier Division.
- ☐ The Clyde Trophy will be awarded to the winners of Division 1.

WEDNESDAY PENNANTS:

EAST ZONE:

- **Start Time:** 1:30pm
- **Venues:** As advertised in the Bowls Central Otago Handbook
- **Match Format:** 3 Sets of 7 ends. All 3 sets to be played out, a tie is acceptable
- **Team Format:** Optional
- **Cost:** \$8/team to cover afternoon tea.
- **Scoring:** Win 2 points, draw 1 point per set. Club teams will be scored individually, the winner being the team with the highest accumulated points.
- **Killed End:** The jack will be placed on the 2-metre mark
- **Incorrectly Delivered Jack:** Placed by the opposing skip

- **Games Interrupted or called off:** In the event of interruption or abandonment for rain or any other reason points will be awarded for each completed/part completed set. Points will be shared for non-completed sets. Any round cancelled will not be replayed.
- **Results:** All results to be entered into Bowls Hub by the Host Club direct from cards.

WEST ZONE: Pennant games and tournaments are held alternatively during the season.

Pennants:

- **Start:** 1.30pm
- **Format:** Play two games of 1hr 20mins Pairs and Fours.
- **Cost:** Visiting teams will pay the Host Club \$8/team to cover afternoon tea.
- **Results:** Results to be entered direct into Bowls Hub by the Host Club from the cards.

Tournaments

- **Start:** 9.30am. **Entry Fee:** \$40/team.
- **Entries:** Entries to Host Club Secretary seven days before the event
- **Format:** Five games of 8 ends.
- **Killed End:** Jack placed on 2metre mark.
- **Points:** 20 win, 10 draw, 1 for each end won.

CENTRE WOMEN'S INTERCLUB

Points: Points will be awarded as win 2 points, draw 1 point.

Catering: Host Club to provide morning & afternoon tea @ \$2.00 per player. A raffle may be held to defray expenses. Players supply own lunch.

Cancellations: Any game cancelled due to unforeseen circumstances must be played or completed before the following interclub game as programmed.

Delivery of Jack: If jack is incorrectly delivered it will be returned and delivered by the opposing player.

Results: Host Club to enter results into Bowls Hub within 24 hours after the match. Only 1 card per game. The score cards are to remain with host club.

Teams: If insufficient lady player's available, in the first instance a lady may be borrowed from another club. A male player may be included, playing lead or second only in the Margaret Robertson Shield Fours.

MORNING 2x4x2 PAIRS:

Start of Play: Games to commence at 10.30 am.

Playing Format: 4 players per team playing 2 games of 2x4x2 pairs.

Time: Matches to be played for 2 hours bell to bell. Complete the end in play when the bell is rung. All games to be completed irrespective of score within the designated time limit.

Burnt Ends: If an end in play is burnt after the bell, the jack will be re-spotted on the 2-metre mark to complete the end.

Points: 2 points for a win. 1 point for a draw. If both sets of pairs win 1 bonus point will be awarded. Where a Club has more than 1 team in the competition, all points awarded will be divided by the number of its teams to equalize its points with Clubs with only 1 team. After these calculations the Club scoring the highest points will be declared the winner. If points are tied Clubs will be declared joint winners.

Lunch: At the end of play.

MARGARET ROBERTSON SHIELD:

Start of Play: Games to commence at 1.00 pm

Playing Format: Fours.

Time: Play for 2 hours bell to bell. Complete the end in play when the bell is rung. All games to be completed irrespective of score within the designated time limit.

Burnt End: If an end in play is burnt after the bell, the jack will be re-spotted on the 2-metre mark to complete the end.

Points: 2 points for a win. 1 point for a draw. Where a Club has more than 1 team in the competition, all points awarded will be divided by the number of its teams to equalize its points with Clubs with only 1 team. After these calculations the Club scoring the highest points will be awarded the Robertson Shield. If points are tied Clubs will be declared joint winners.

Afternoon tea: At conclusion of play.

CENTRAL WOMENS LEAGUE (CWL)

Dates: Dates and venues are advertised in Bowls Central Otago Handbook 2026/27

Format: 2 x bowl Fours
4 x games of 10 ends or 1hr 30 min

Killed End: Jack placed on 2 metre mark

Delivery of Jack: If jack is incorrectly delivered it will
returned and delivered by the opposing player.

Game Interruption: In the event of interruption or abandonment for rain or any other reason, points will
be awarded for each completed/part completed game.

Host club: Responsible for running of the tournament and entering results directly into Bowls
Hub.

Dates: As per the Draw advertised on Bowls Hub or Bowls Central Otago 2026/27
Handbook.

Start Time: Games to commence at 1.30 pm unless otherwise advised.

Playing Format: Sides game: 1 x team of Fours – 2 bowls, 16 ends
1 x team of 2x4x2 Pairs – 4 bowls, 14 ends

Time Limit: No time limit

Delivery of Jack: If jack is incorrectly delivered it will be returned and delivered by the opposing
player.

Burnt End: If an end in play is burnt the end shall be replayed.

Points: 2 points for a win for each team.
1 point for a draw for a draw for each team
1 bonus point, overall, if both teams in the side win (Fours and Pairs)

Substitutes: If teams are unable to field a full team of 6 players, substitutes may be introduced
from the pool of extra players or a man from the same club. Substitutes cannot play
in the position of skip.
Club captains to liaise with Dawn Coburn (Middlemarch) to advise if they have excess
players to go into the pool or need to obtain a substitute, by Tuesday before each
game.

Forfeit: If teams are unable to field a full team of 6 players and are unable to obtain a
substitute, they will forfeit the game and the opposition will receive 4 points.

Cancellations: Any game cancelled due to unforeseen circumstances must be played on a
designated day, before the end of the season, as determined by the emergency
committee (President, Secretary, Tourn Secretary).

Catering:	Teams to bring 1 plate to be shared for afternoon tea. The host club may hold a raffle to defray expenses. Afternoon tea to be held halfway through the afternoon's play.
Results:	Only 1 card per game. The score cards are to be given to designated Bowls Hub administrator at the end of the day.
Laws of the Sport:	All players must abide by the Laws of the Sport of Bowls.
Controlling Body:	The Controlling Body reserves the right to amend the Conditions of Play to suit unforeseen circumstances.

CENTRE OPEN TOURNAMENTS:

Venues:

Entries close: MEN & WOMEN: On Bowls Hub no later than 7.00pm Sunday 15 November 2026

Entry fee: \$35.00 per player payable in full.

Payment Terms: Payment of \$35.00 to be made to Bowls Central Otago (Bowls CO) Account No: 02 0916 0133831 00 no later than 5.00pm on Monday 16 November 2026. If full payment has not been confirmed by this time the entry will not be included in the draw.

Start of Play: Play will commence by 8.30am each day.

Time Limit: 2 hour time limit up to Semi-Final and Final. The commencement of play and expiry of time shall be signalled by the Umpire by some means clearly audible to the players concerned.

Where the time limit is not common to all games on any green, the agreed start time must be recorded on the scorecard and scoreboard. The Umpire shall notify the players in individual games when the time limit has expired.

Markers: Competitors must bring 1 marker between 2 players.

Qualifying Play Format: 4 x round robin games. 21 shots 4 bowls. Winners of 3 or 4 Games qualify for Post Section play.

Post Section Play Format: Sudden death, 21 shots 4 bowls. No time limit for Semi Finals and Finals only.

Defaults: If a player defaults their score will be recorded as a loss and the non-offending player will be awarded a win.

Restricting the movement of players during play: (Appendix A A.4) Movement of players, during all play, shall be restricted. Players will be allowed to walk up to the head only after delivery of their third and fourth bowls. In exceptional and limited circumstances, a player can ask the marker if they can walk up to the head earlier than described in Appendix A4.1. If a player does not meet the terms of this law, Law 13 of the Laws of the Sport of Bowls shall apply.

Burnt End: If an end in play is burnt after the bell, the jack will be re-spotted on the 2 metre mark to complete the end.

Extra End: (Law 28) If the end in play when the time limit bell sounds is completed and the scores are equal then, an extra end or ends will be played to decide a winner. Players will toss a coin to establish who will play first. There will be no kills on the extra end and the jack will be re-spotted on the 2 metre mark. If a bowl is already on the 2 metre mark the jack will be placed on the mat side of the bowl sitting on the 2 metre mark without touching the bowl.

Where the time limit is not common to all games on any green, the agreed start time must be recorded on the scorecard and scoreboard. The Umpire shall notify the teams in individual games when the time limit has expired.

Qualifying Play Format: 4 x round robin games. 18 ends, 3 bowls. Winners of 3 or 4 Games qualify for Post Section play.

Post Section Play Format: Sudden death, 18 ends 3 bowls. No time limit for Semi Finals and Finals only.

Defaults: If a team defaults their score will be recorded as a loss. The non-offending team will be awarded a win.

Restricting the movement of players during play: (Appendix A A.4) Movement of players, during all play, shall be restricted.

Players will be allowed to walk up to the head:

- Lead after delivery of their 3rd bowl
- Skips after delivery of their 2nd & 3rd bowls

In exceptional and limited circumstances, a player can ask their partner to walk up to the head earlier than described in Appendix A4.1. If a player does not meet the terms of this law, Law 13 of the Laws of the Sport of Bowls shall apply.

Burnt End: If an end in play is burnt after the bell, the jack will be re-spotted on the 2 metre mark to complete the end.

Extra End: (Law 28) If the scores are equal at the end of the completed number of ends or at the end in play when the time limit bell sounds then, an extra end or ends will be played to decide a winner. Skips will toss a coin to establish which team will play first. There will be no kills on the extra end and the jack will be re-spotted on the 2-metre mark. If a bowl is already on the 2 metre mark the jack will be placed on the mat side of the bowl sitting on the 2-metre mark without touching the bowl.

MEN'S CAPTAIN JOLLY MEMORIAL CUP:

This competition is for the Captain Jolly Memorial Cup, presented to the Centre by the Cromwell Club, in the memory of Captain William Jolly, killed in action in 1915.

Rules and Conditions:

1. It is a Single Four inter-club competition.
2. The season will commence on the last Saturday in October and conclude on the Saturday preceding Anzac Day, both days inclusive.
3. Challenges must be in writing from the Club Secretary to the Centre Secretary, who will forward the Challenge to the holders. Challenges will be played in the order in which they are received. At the beginning of the season, challenges may be sent seven (7) days prior to the last Saturday in October. If two or more challenges are lodged, there will be a ballot to determine the order in which games will be played.
4. All games will be of 21 ends, except in the case of a tie or drawn games, when play will continue until a decision is arrived at.
5. Play will commence not later than 6.00 pm unless otherwise mutually agreed upon.
6. The prior challenge shall be played within nine (9) days or before the end of the following week whichever is the sooner, the holders to give the challengers the choice of two (2) days.
7. Neither the holder nor the challengers can be compelled to play on the day of a centre shield or other fixture. Play during Christmas week, December 25 to January 2, shall be optional to both holders and challengers.
8. The defeated holders cannot issue a challenge within seven (7) days of defeat.
9. No Club may have more than one challenge listed at any one time.
10. Any club defaulting a match shall not be able to challenge again until four (4) weeks have elapsed.
11. All games will be played according to the Laws of the Game and no play will be allowed before a match.
12. If a member or members of the holder's four are not available to play in any challenge, substitutes may be played, and the position in the fours altered in any way to suit the holders.
13. If weather conditions prevent play on the day, the challengers shall have seven (7) days extra, all other challenges to be played in the same order as previously drawn. If the holder's green is

unfit for play through any unforeseen reason, the match must be played on another green, the holders to have the choice of green.

14. All disputes shall be referred to the Centre Executive. Protests must be lodged in writing within seven (7) days.
15. Trophy and badges must be produced on the holder's green at every game. During the off-season the club holding the trophy and badges is responsible for their safe keeping.
16. In the event of damage to, or loss of, the trophy, other than by fire, the trophy is to be replaced, as the case may be, by the holders. In the event of damage to, or loss of, the gold badges, the badges are to be repaired or replaced by the holders.
17. The holders must have at least two (2) rinks prepared with not less than 4.2 metres of prepared green outside each other rink peg. The rinks must be not less than 4.2 metres in width.
18. The Competition is open to all clubs, affiliated to the Bowls Central Otago Centre, and financial on the Centre's books.
19. A team from the holder's club can challenge, providing that no challengers are in hand, but such challenge to be immediately superseded if a challenge from any outside club is received.
